C.A.P. Meeting Minutes from May 13, 2019

Two checks have cleared, one for \$3000.00 to CHS for the new banners and also a \$70.00 check that is the last fee from the Hall of Fame Dinner. Mark motioned and Charisse seconded that the Treasurer Report be approved. The motion passed unanimously.

Meeting Minutes: The April minutes were reviewed. Tony motioned and Mark seconded that the minutes be approved. The motion passed unanimously.

Athletic Program: The gym restoration is almost complete. The Boys Swim and Dive Team and the Girls Swim and Dive Team were both top three Academic All State in Michigan. Boys Track and Field and Girls Track and Field Teams are City and Division Champs. Marc is again trying to get the Track and Field Conference Meet moved from the same date as Senior Prom.
